The NHS and local councils are developing and implementing shared priority work streams to improve health and care in every part of England

Clinical Commissioning Groups

CCGs have a duty to use evidence from research for commissioning decision making

Primary Care Networks

Groups of practices 30-50k patients to deliver key services in community- will need to be evidenced based



Policy

Knowledge for Healthcare, sharing our vision that *NHS bodies, their staff, learners, patients and the public use the right knowledge and evidence, at the right time, in the right place, enabling high quality decision-making, learning, research and innovation to achieve excellent healthcare and health improvement.*

#A Million Decisions is a campaign launched by **Health Education England** to promote the use of Library and knowledge services in ensuring that 1 million decisions (clinical and corporate) made in the NHS every day are evidence based
