



Approximately how many of these are doctors and nurses?



Across NHS hospital, community and primary care settings, there are around 150,000 doctors in total and over 320,000 nurses and midwives. These two groups – while large – constitute only just over a third of the total workforce.

How many Library Knowledge Service (LKS) staff were employed in NHS England in April 2019?



In April 2019 there were just under 1005 WTE LKS staff in the NHS in England. 62% of these are professionally qualified.

In WTE terms LKS staff account for around 0.091% of staff employed.
